Each geographical area receives one representative per 1,000 players.</p> <p>The Kentucky “Adult League Committee” member’s term will be for two years. This committee will meet approximately three times per year. In addition to the scheduled meetings you will be asked to participate on a regular basis via email or Zoom with the committee and the USTA Manager Adult Leagues on various items needing input or a vote, such as:</p> <ul style="list-style-type: none"> Regulations Deadline extensions for local leagues Various issues as they pertain to adult leagues <p>The Chair shall appoint the Grievance and Grievance Appeal Committees from members of the ALC as needed.</p> <p><i>*Member at Large has no voting power, may be asked for input during committee meetings as needed.</i></p> <p><i>All Members must take an active role and work KY League State Championships, engaging with players and providing support.</i></p>
<p><u>Championships</u></p> <p>Dustin Ingram - Chair Emily Barnett Susan Florence Melanie Humbert Laurel Humbert-Stock Kris Hamilton</p>	<p><i>Recommend changes to improve player experience to ALC.</i></p> <p>Come up with recommendations on making our championships a NEW experience for ALL participants, including those that have advanced year after year. This is the main charge for these next two years for this subcommittee.</p> <p><i>2025 These committee members are expected to work more than the expected two league championships, to be the FACE of USTA KY and engage with our players at championships.</i></p>
<p><u>Championship Schedule Review</u></p> <p>Stacey Rice Emily Barnett Leony Barroso Billy McGlone</p>	<p>Responsible for reviewing ALL League Championship schedules prior to publication. <i>This will require timely communication seven to ten days prior to all championships. This requires a working knowledge of flighting/non-flighting scheduling.</i></p> <p>At minimum two members will review all state championship schedules prior to publication.</p>
<p><u>Rules & Regulations</u></p> <p>Stacey Rice – Chair Jessica Bethards Sarah Owens Anna Greene</p>	<p>Review current practices, procedures, and regulations to ensure compliance with the USTA National and Southern regulations. Recommend changes to ALC regarding league regulations.</p> <p><i>2025 Charge for this committee: Review all regulations in detail and clean up verbiage as needed, look for conflicting and/or duplicate wording.</i></p>
<p><u>Grievance</u></p> <p>Jerry Groce – Chair Dustin Ingram Judy Cates Sara Owens Jessica Bethards</p>	<p>A minimum of three members will hear any grievance elevated to state level including those filed at any state championship.</p> <p><i>Grievance training will be provided and is a requirement for this committee.</i></p>
